STUDENT'S FEEDBACK ON CURRICULUM FOR THE YEAR 2019-20

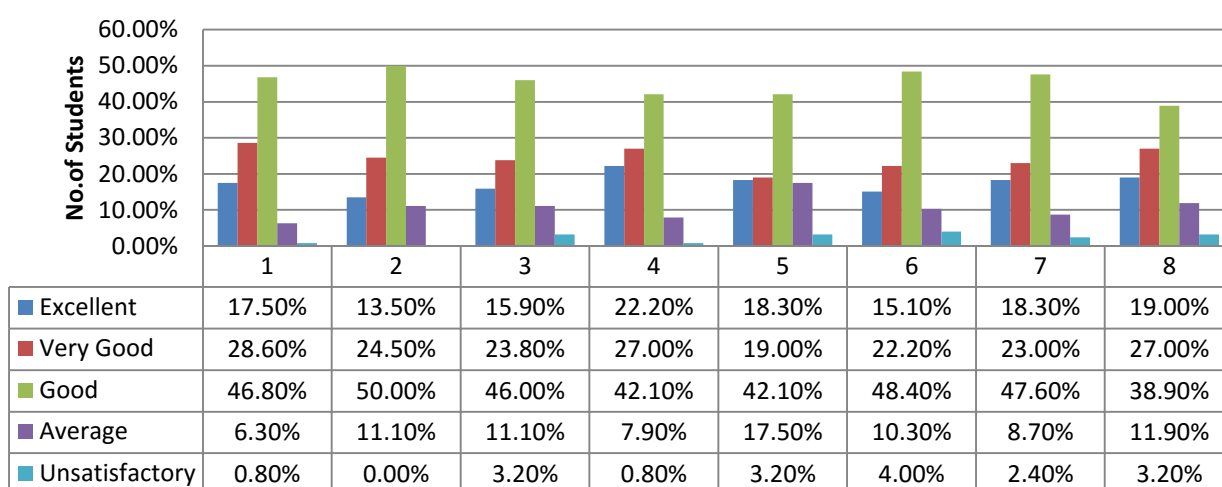
The forms of student's feedback on curriculum were provided to 536 number of students in online mode during academic session 2019-2020.

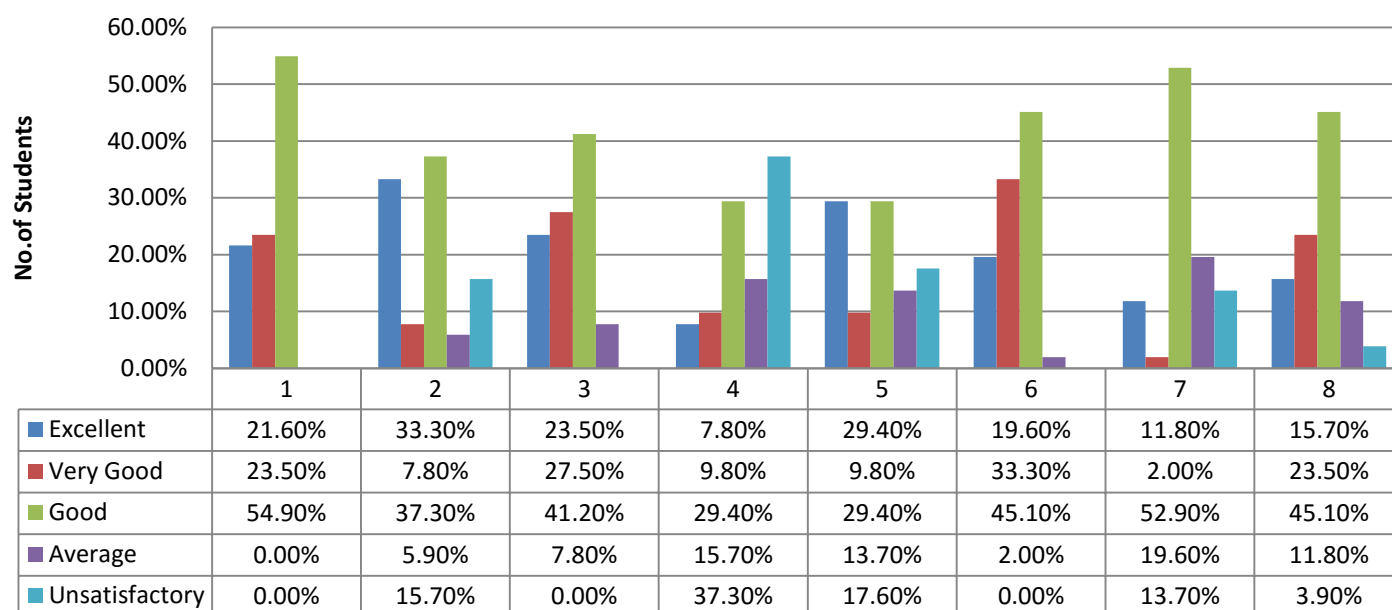

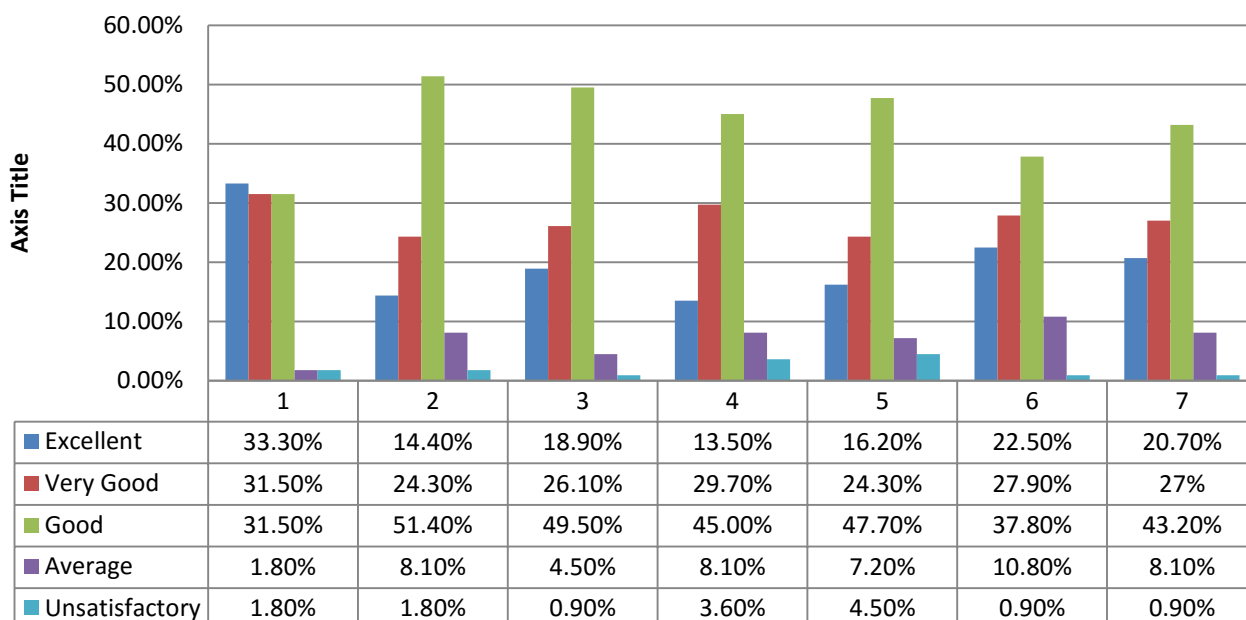

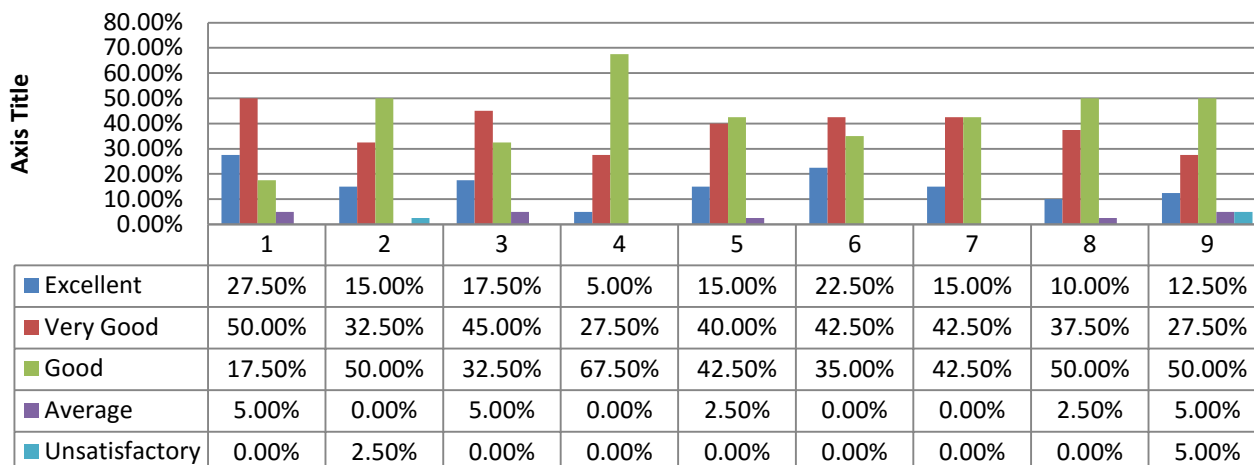

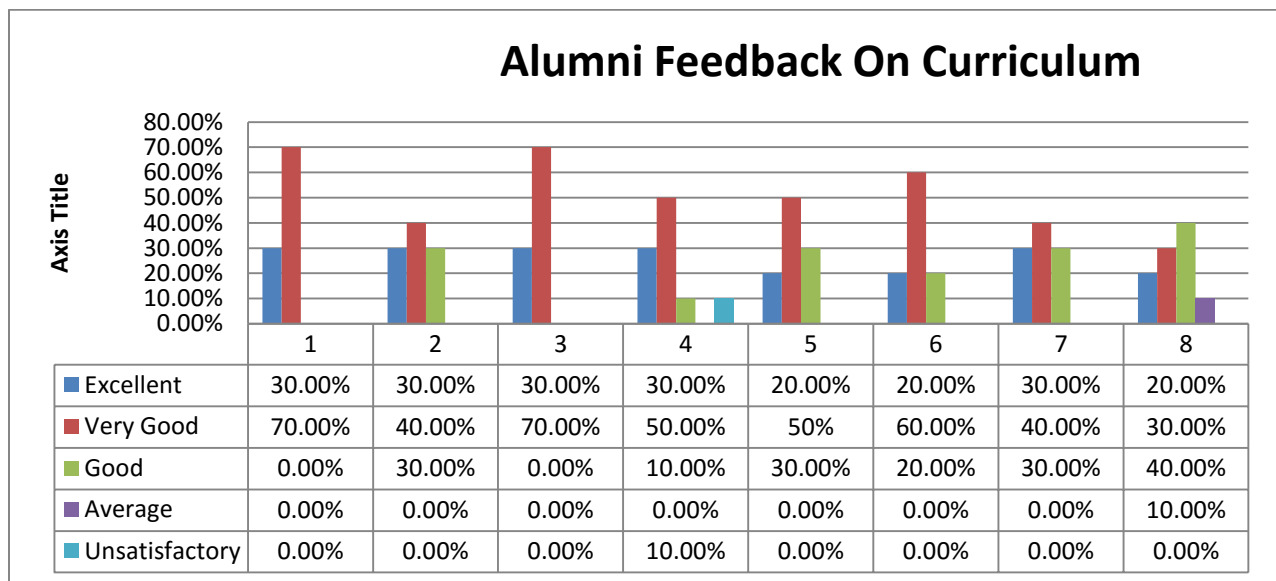

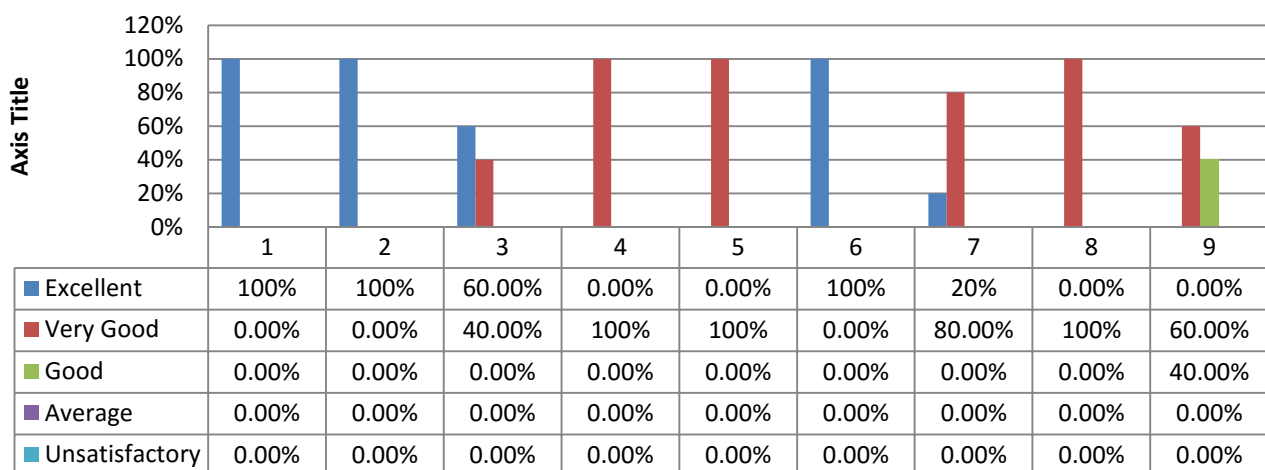

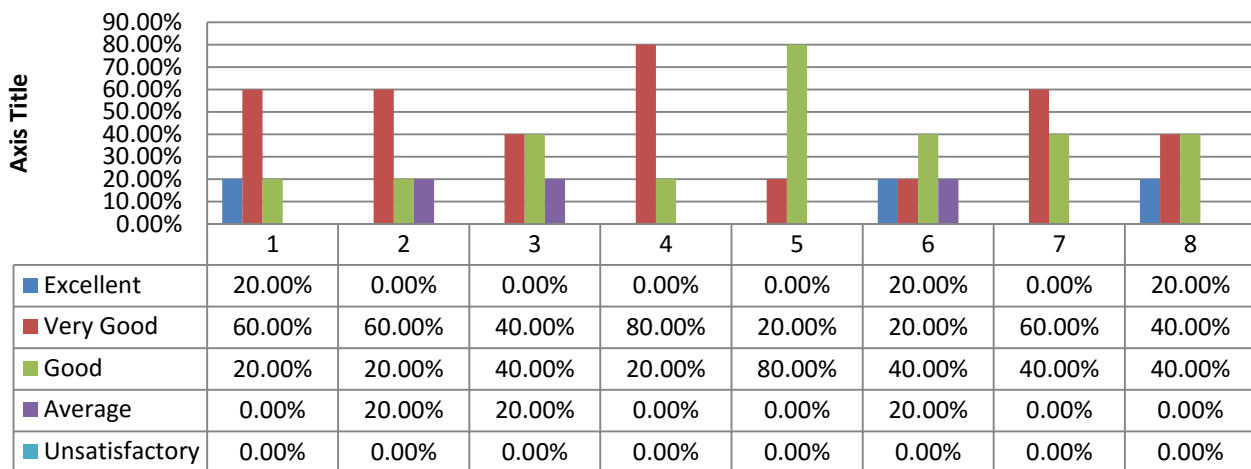
