STUDENT'S FEEDBACK ON CURRICULUM FOR THE YEAR 2020-21

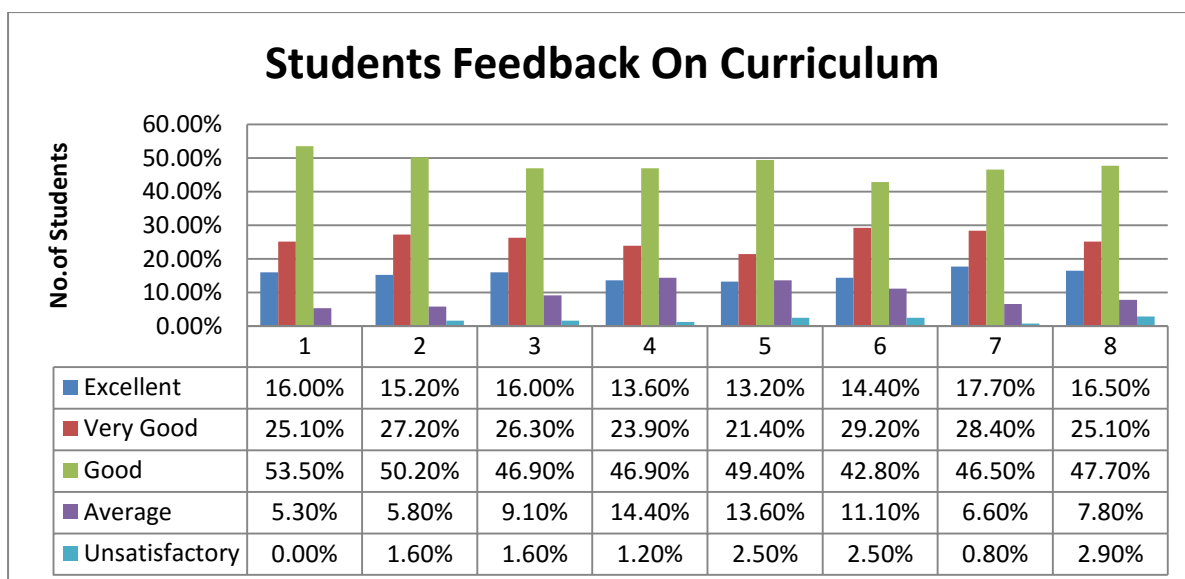
The forms of student's feedback on curriculum were provided to 530 number of students in online mode during academic session 2020-2021.

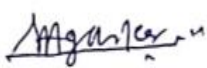

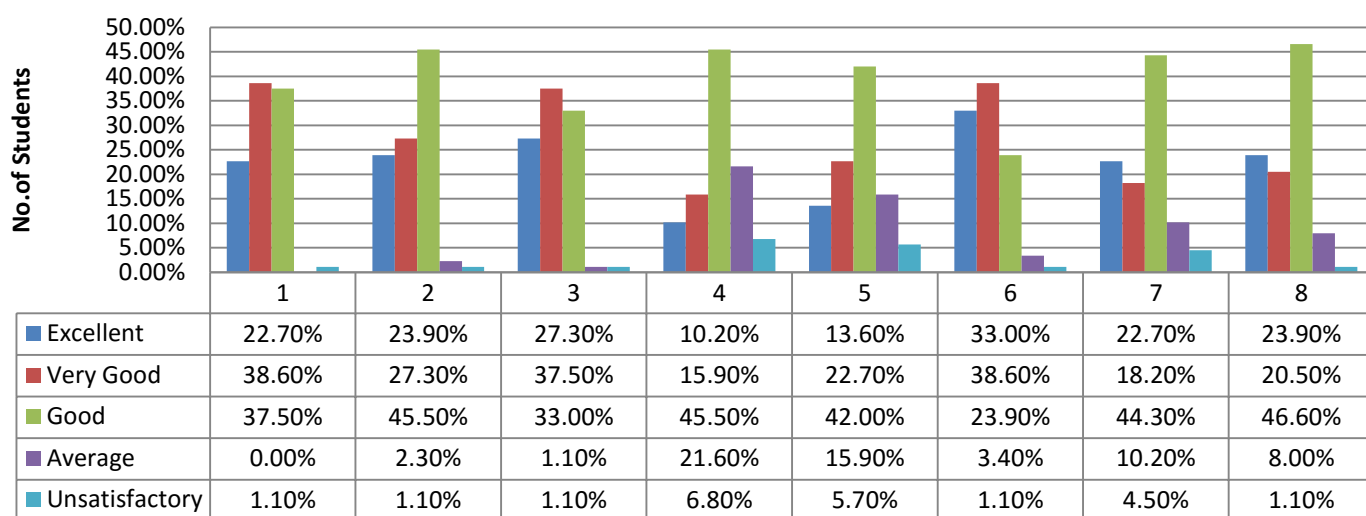
The forms of student's feedback on institution were provided to 154 number of students in online mode during academic session 2020-2021.

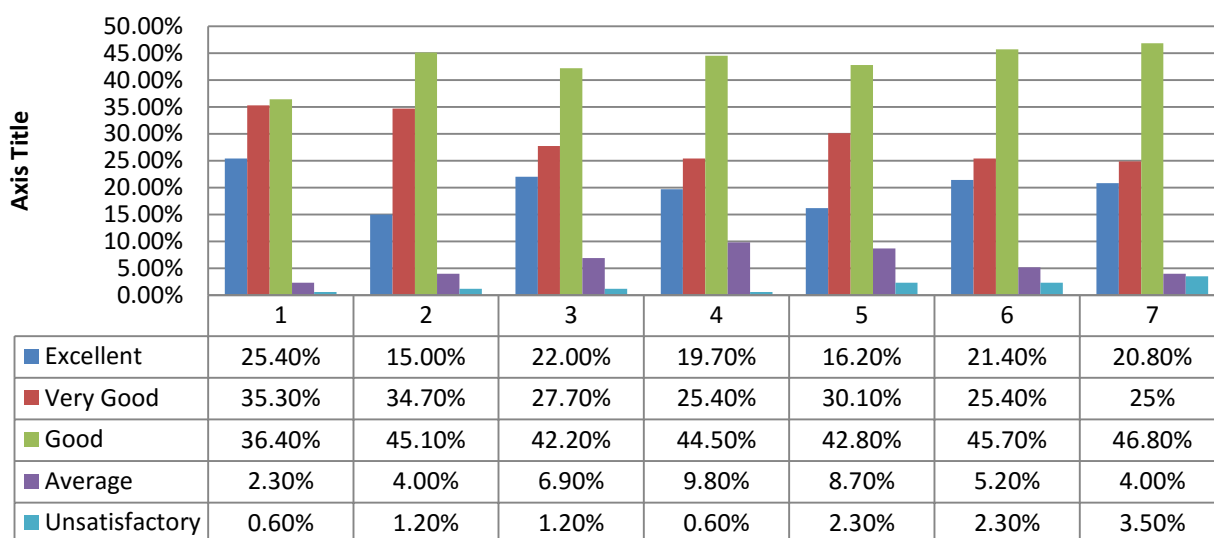

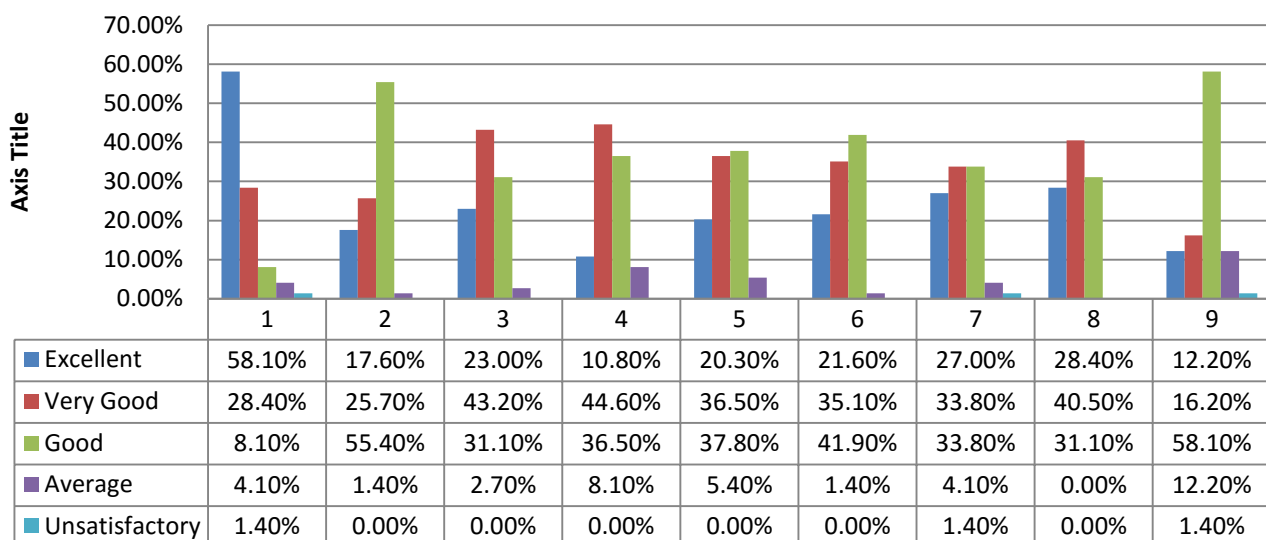

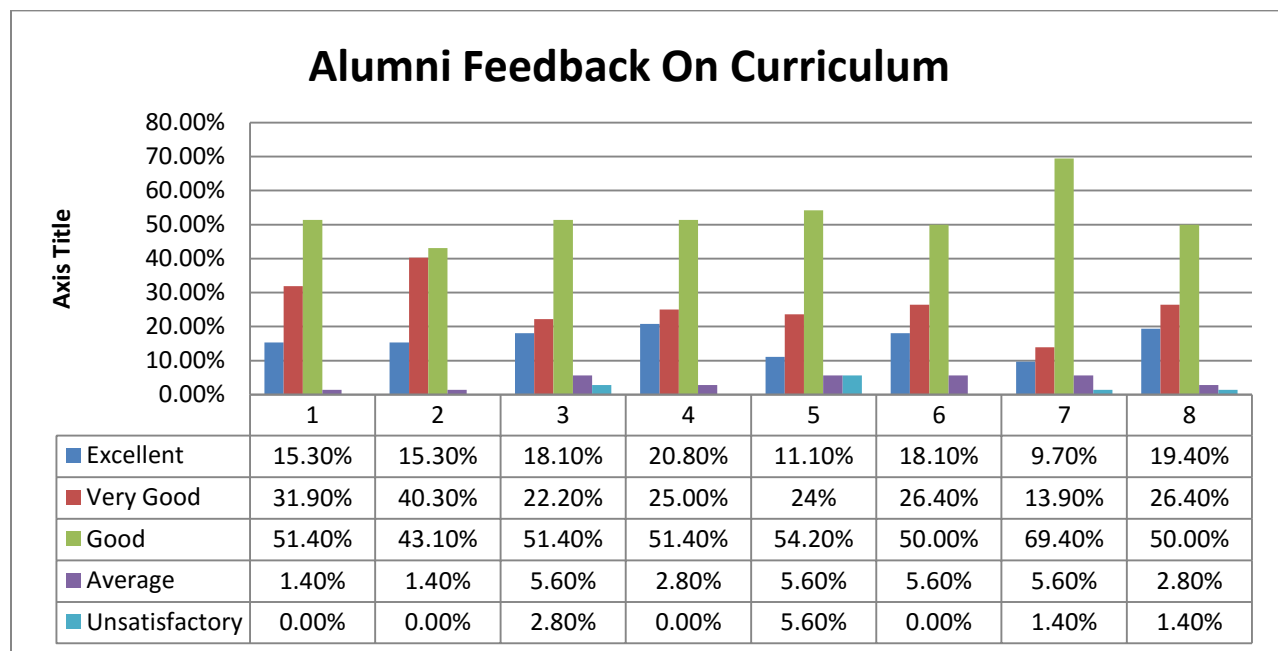

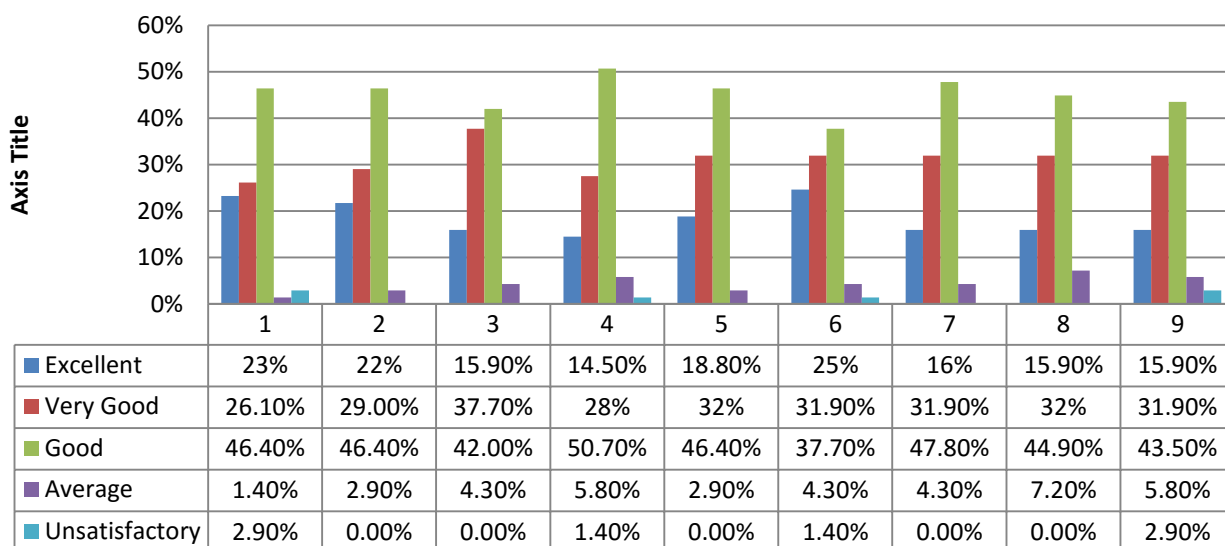

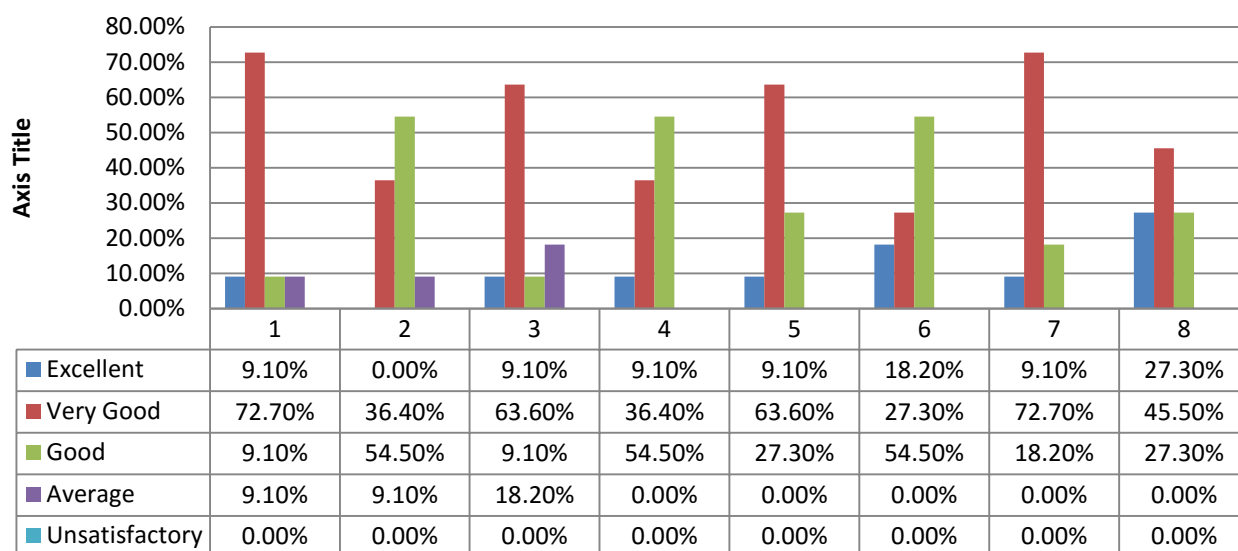
